State Budget Impact on Oklahomans with Disabilities



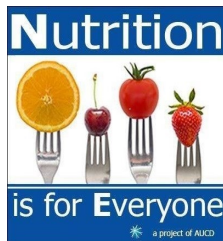

Self Advocates Becoming Empowered Conference 2018



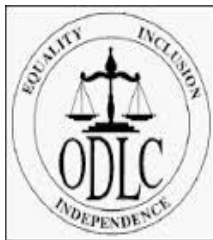
