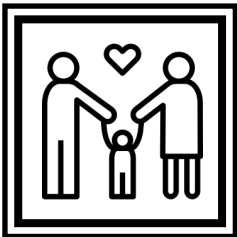


US Department of Labor to Issue Excellence in Disability Inclusion Award
