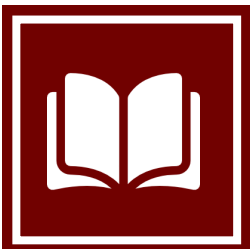
## Partnership Award Nominations Open

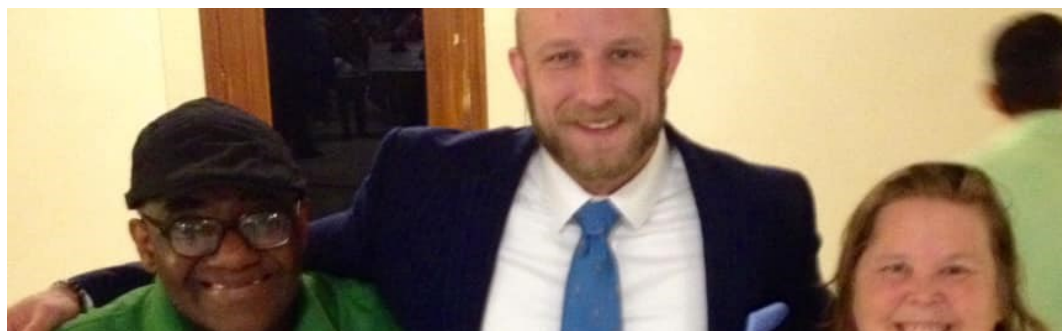
