In honor of the United Nations International Day of Persons with Disabilities, Microsoft announced that they are adding automatic subtitles and captions to increase accessibility in PowerPoint, their presentation software. The new features are generated by an artificial intelligence program, which also allows for automatic translation into 12 spoken languages and over 60 written languages. ## Oklahoma Continues to Offer Family Support Assistance Program

The Family Support Assistance Program is a monthly cash payment for certain children who have intellectual disabilities or other developmental disabilities and who live in areas of Oklahoma with limited incomes and resources. Assistance consists of a monthly cash payment between \$250 and \$400 to be used at the family's discretion. The amount is based on the number of children living in the home who meet program qualifications. The family/child is not eligible if receiving adoption subsidies or the DDS waiver services. 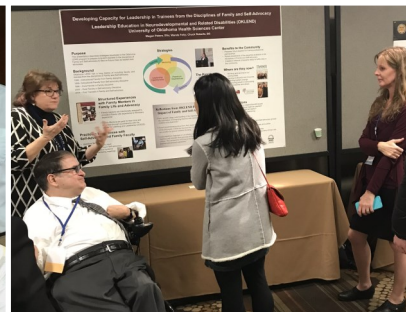
### Center for Learning and Leadership and OKLEND Staff
