Barbie's Dreamhouse is now more accessible. Mattel is making their first-ever African-American Barbie with natural hair who uses a wheelchair. The doll features a wheelchair without handles and a ramp that is sized to fit the Dreamhouse. Barbie's first wheelchair, made in the 90's, did not fit in the house, and the new doll is a step forwards for disability representation for young children. Comcast has released a virtual keyboard for laptops and computers to navigate connected TVs with eye gaze. 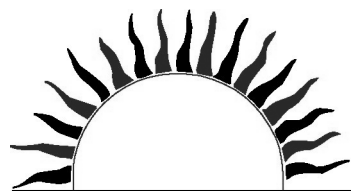

Oklahoma Self Advocacy Network Works with Richelle Frabotta

OKSAN is proud to work with Richelle Frabotta of Miami University in Ohio. Richelle has been a professional community-based Sexuality Educator since 1992. She focuses on individuals with divergent learning styles. She has authored curricula, trained staff, and provided group education to parents, caregivers and self-advocates and consultation services for folks in the Intellectual -Developmental Disabilities, Learning Disabilities, Autism Spectrum, and Traumatic Brain Injury communities. In 1997, she established a full-service sexuality education program for an Ohio County Board of Developmental Disabilities.

Richelle is working with OKSAN trainers to create a peer-to-peer training that will address personal relationships, that will include health, safety, preferences and boundaries. The trainings will be developed, taught, and evaluated by self-advocates. Richelle is happy this kind of education opportunity is being offered to self-advocates by self-advocates, and OKSAN is proud to work with her. OKSAN trainer Kelly Zakis says she is excited to "learn more about it and not be afraid to talk about sex," and Sam Jenkins says "she is fantastic and I want to know more on how to train on this topic and not be afraid to say the terms".
