### IPE Trauma Simulation Pilot Held on Thursday and Friday



- The pilot experience was held on Thursday and Friday, July 18-19, 2019 at the Clinical Skills Education & Testing Center (CSETC), led by Professor Bruna Varalli-Claypool, her planning team, and the CSETC staff.
- The case allowed an interprofessional team to address a multi-systems trauma patient with objectives related to the IPEC competencies.
- In collaboration with the Office of Diversity and Inclusion, we were joined by 18 high school student observers from the Aspiring Health Professions Summer Academy.
- Our Curriculum Committee will work with program contacts across campus to build this case into a future simulation experience for HSC student participants.
- Thank you to all involved for a successful pilot program.

## IEPA Committee Updates

*The Interprofessional Educators & Practitioners Association (IEPA) welcomes faculty from all programs to participate in the planning and delivery of campus-wide interdisciplinary programming through service on our committees.*

### IEPA Executive Council

- Last met 7/17/19. Next meeting 8/28/19.
- All Committees Meeting is scheduled for 7/26/19. The draft PPT has been sent to each committee. Group discussed upcoming proposals, opportunities, and terminology.
- Dr. Linda Wilson from the Office of the Vice Provost for Academic Affairs & Faculty Development presented on the OUHSC Academic Strategic Plan Implementation Report. Each of the five implementation committees were discussed with relation to possible collaboration with IEPA. The “spotlight” document has been drafted and is attached.

### Curriculum Committee

- Last met 7/15/19. Next meeting 7/29/19.
- Syllabus for the online Introduction to Interprofessional Education course was reviewed and approved. Course will launch in August.
- A flyer was created for All Professions Day. Will be updated and sent.
- A new committee concept map was distributed and discussed. The proposed committee structure will assist with programmatic development and sustainability. The proposal will be given at the All Committees Meeting for additional feedback.
- Proposals for Collaboration review team was determined. Proposal applications will be sent for scoring with return requested by August 5, 2019.
- Simulation plans include the pilot on 7/18-7/19/19. Collaboration with the IHI chapter on the patient safety “Fright Night” and “Valentine Massacre” simulations continues.
- Proposal for the Friday continuity clinic is under final review and will be sent to program contacts for review in the coming week.

### Faculty Development Committee

- Last met 7/18/19. Next meeting 8/1/19.
- Group continues to consider upcoming projects including:
  - Education series focused on mindfulness in team communication
  - Membership engagement
  - Recognition & Awards
  - Additional facilitation and educational training opportunities

### Research Committee

- Last met 7/15/19. Next meeting 8/5/19.
- Consideration of the All Committees proposal reviewed the research strategy priorities set at the previous meeting. Data analysis of the 2018-2019 study continues to be in-progress. The finalized strategy will depend on data results. Ultimate goal is to define competence among program participants.
- The secondary analysis subcommittee met on 7/15/19. Group continues to review qualitative data using themes of the IPEC competencies. Group is currently gathering frequency counts.

### ASPi & IEPA

As a campus-wide endeavor, the Office of Interdisciplinary Programs supports the operationalized, systemic goals supporting our shift from cylinders-of-excellence to comprehensive and meaningful interprofessional programming.

**ASPi: Strategy**

Working to redefine culture and goals in support of campus-wide interdisciplinary practices, including supporting enterprise-level pilot projects.

**IEPA: Operations**

Developing and implementing sustainable, competency-driven interdisciplinary/interprofessional activities to meet degree and program needs.

### Academic Strategic Plan Implementation

The OUHSC Academic Strategic Plan implementation (ASPi) is coordinated through the Office of the Vice Provost for Academic Affairs & Faculty Development. The 2018-2022 implementation plan includes five goals, one of which is to “leverage growing interest in interprofessional collaboration.” This goal has an implementation committee referred to as ASPi#2.

### ASPi#2 Committee

ASPi#2 committee chairs are Dr. Dora DiGiacinto, College of Allied Health, and Dr. Aaron Wendelboe, College of Public Health. The committee includes a representative from each college, many of whom also participate in IEPA.

### Sub-Goals

Original sub-goals from the ASPi#2 Goal were made succinct and measurable, then prioritized by committee members. Two sub-goals are currently be pursued as actionable items, below.

#### #1 Develop a Cadre of Faculty

To fully understand the depth of our interprofessional activities already underway, and to best inform future development, ASPi#2 has proposed implementation of a campus-wide digital tracking system. Benefits include comprehensive reporting, identification of interprofessional activities, tools for standardized annual reports used for evaluation and promotion/tenure, and tools for downloading standardized CVs.

Software and infrastructure support is currently being considered at the enterprise level with proposed pilot roll-out among IEPA faculty tentatively slated for 2019-2020.

#### #2 Menu of Opportunities

To create additional opportunities for interprofessional interactions, ASPi#2 has proposed a course alignment initiative. An ad hoc committee has been formed to consider a process by which a full course can be leveraged for alignment between programs. Possible examples might include Responsible Conduct of Research, Ethics, or Healthcare Quality.

*Note: The full-course alignment pilot project is in addition to and separate from the projects currently coordinated through the IEPA Curriculum Committee.*
